WEBINAR 1: BEST PRACTICE GUIDELINES ON DEBT MANAGEMENT FOR THE PUBLIC SECTOR

Monday, 21 September 2020 and Tuesday, 22 September 2020 (10:30am - 11:30am each day)

This is an online version of the popular classroom session which provides an excellent overview for staff new to debt management and a refresher course for experienced staff which will provide some new ideas – all based on a proven approach to improving efficiency and effectiveness in debt management.

It is based upon the Debt Management Best Practice Guide developed by the Webinar Leader under the auspices of Department of Public Expenditure and Reform (DPER), working with a number of public bodies including local authorities.

The content has been updated to take account of considerations arising from COVID-19 (e.g. businesses in trouble, remote working, less face-to-face contact).

- A clear understanding of the background to and content of the "*Debt Management Best Practice Guide*" and supporting materials
- An appreciation of each of the twelve key best practices contained in the Guide
