FOREWORD

In another very difficult and challenging year the process of adjustment required under the terms of the financial support programme for Ireland gained momentum, and this had great significance for the Irish public service. A major reduction in the costs of the public service is one of the central requirements of the €85 billion financial support programme for Ireland overseen by the EU, ECB and IMF.

The process of staff reduction across the public service continued and intensified throughout the year. It was expected that by early 2012 a further 9,000 staff would have left the public service. The reductions in staff numbers occurred across all sectors – the civil service, the health service, local authorities, the defence forces and the Garda Síochána.

This also means that the public service will have to find new ways of working, embracing innovation and collaboration, and planning to use scarce resources – particularly staff resources – as effectively as possible. These challenges underpinned the *Public Service Reform Plan* published by the Department of Public Expenditure and Reform in November 2011. That plan presented a challenging set of targets for all sectors.

In that context the Institute continued to play a very critical role in providing opportunities for dialogue and debate about the choices and challenges facing the public service. Indeed, the theme of our annual conference in 2011 was *Next Stages in Public Service Reform – Challenges and Choices*, which was addressed by Brendan Howlin, TD, Minister for Public Expenditure and Reform. The IPA's Governance Forum also provides senior managers with the opportunity to keep up to date with best practice in governance and management, and maintaining high standards of governance becomes even more critical at a time of such rapid change and 'churn' in the system. The Governance Conference focused on the theme *Setting the Tone from the Top* and was addressed by Minister Brian Hayes, TD.

Change also highlights the need for leadership, and the IPA continued to deliver leadership programmes for senior public servants across the system during the year. These programmes support managers in thinking through the challenges they face, but also help them to design interventions that will achieve the change targets set out under the reform plan. The IPA continues to see the development of leadership capacity within the public service as a priority issue, particularly with the significant changes in personnel at senior level, referred to above.

FOREWORD

In 2011 the Institute also launched its new strategy for the period 2011–2015. The Institute was originally established to develop and improve professional standards of public service, and this remains the core mission of the Institute. Therefore, in the new strategy there is an emphasis both on the development of professional standards through education and academic research and on practical development in areas such as leadership, management, governance, financial management, human resource management and IT. The further development of capacity in all of these areas will be critical to achieving the targets in the *Public Service Reform Plan*.


In relation to the pursuit of professional standards, the Institute also announced a formal strategic alliance with University College Dublin (UCD) in 2011, and in the autumn the IPA became a recognised college of UCD. This means that public servants will have access to the progression and transfer opportunities that flow from being linked to such a large and internationally renowned university with a wide range of programmes and courses. In addition, by being linked to UCD accreditation processes, our students will also have assurances about the quality and international standing of the qualifications they gain. Already, the highest qualification offered by the Institute, the Doctorate in Governance, has become the first jointly offered IPA-UCD programme.

We hope that the new alliance will bring many advantages to existing and new students, and allow us to better pursue those goals of providing intellectual stimulus, promoting high standards of public service and developing international connections that inspired the founders of the Institute. We also hope that the IPA and UCD can support our public service through current challenges and into a new phase where we are recognised not just for the efficiency and effectiveness of our services but for having a public service that is firmly grounded in purpose.



DIRECTOR GENERAL'S REPORT

The year 2011 represented another difficult year for the Irish public service, and a challenging year for the Institute. The ongoing cutbacks in public expenditure meant further reductions in the budgets for training, education, research and other services provided by the Institute. Despite these challenges, progress was made on a number of fronts, not least with the implementation of the Institute's strategy for 2011-2015, titled *Professional Development and Public Service Renewal*, which was launched at the start of the year.

While a further fall was recorded in income from fees for services and Exchequer grant-in-aid, the Institute has put in place a major cost-reduction programme, and during the year further reductions in salaries and other costs contributed to achieving a satisfactory financial outcome by year-end. Over the past two years, and despite the economic uncertainty, the Institute has succeeded in stabilising its finances, and plans for further financial and organisational consolidation are progressing.

In the introduction to our new strategy, we put a particular emphasis on the professional development of public servants as a necessary underpinning to the renewal and development of our public service. Key to professional development is the role of education and research. In this regard during 2011 real progress was made on further developing the programmes and services of the IPA's Whitaker School of Government and Management. A new MSc in Business Studies was introduced, along with a new Professional Certificate in Governance and a Certificate in Housing. We continued with the State of the Public Service research series, which included a major review of the key challenges in Irish public administration, entitled *Fit for Purpose?*, published in April. The *Public Sector Trends 2011* report, published in November, is part of a series that compares standards of quality, efficiency and performance of the Irish public sector with those of other countries, and provides an important evidence base to inform debate and discussion on this important topic. In 2011 we also introduced a new research series for local government, which was launched with a paper on the *Review of International Local Government Efficiency Reforms*.

In publishing, an international editorial board was established for our journal *Administration* with a view to reorienting the journal and its content over time. A number of key titles, including a new text on the United Nations by Noel Dorr and the anthology *Lord of the Files*, edited by staff members Michael Mulreany and Denis O'Brien, were published during the year.

In the sphere of higher education, both globally and nationally, there is a trend towards consolidation and the achievement of critical institutional mass. In particular there has been a trend towards smaller, specialist higher-education colleges developing closer links with larger universities. In recognition of these factors, but also by way of positioning the Institute as a highly credible and unique provider that builds professional capacity in the public service within recognised academic and professional frameworks, the Institute became a recognised college of UCD in Autumn 2011. The Institute has been a recognised college of the National University of Ireland (NUI) since 2001 and by now becoming a recognised college of UCD will remain within the broad NUI constituency.

The rationale and vision for a closer relationship between the IPA and UCD is that Ireland needs to ensure that its public service is leading global practice. On a very practical level, all students enrolling on IPA programmes in future will receive their awards from UCD. For new IPA students the access to pathways of learning available through a major university such as UCD will be a major bonus. A critical aspect of the continuous upgrading of public service performance is access to world-class research skills and knowledge development, and it is anticipated that the new IPA-UCD partnership will play an important role in supporting the transformation of the Irish public service. The IPA will remain an independent body with its own Board and governance arrangement, but the partnership with UCD will open up many new opportunities for clients in Ireland and internationally in the areas of joint academic programmes, joint research activities, joint delivery on international programmes and sharing of technology, library and other facilities.

It was recognised in the introduction to our new strategy that a key part of maintaining and enhancing our reputation as a professional institute was to maintain a focus on providing public service organisations and public servants with practical advice and support to help them meet current and future challenges. It is in this regard that our programme of conferences and seminars, training and development services, and various professional networks across the public service are critical. Our annual conference, held in October, addressed the theme of *Next Stages in Public Service Reform* and was addressed by Brendan Howlin, TD, Minister for Public Expenditure and Reform, and by a range of other contributors from the world of public administration and politics. Our regular breakfast seminars addressed topical issues throughout the year, such as the implications of the national budget for the public service, workforce planning and a leadership masterclass by Professor Gary Orren from Harvard University.

In light of the ongoing domestic downturn, there was a significant emphasis in the Institute's strategy on further growing the potential of our international business. In May 2011 a new international strategy was approved by the Board. This strategy seeks to continue and further intensify our existing focus on capacity building and training for public administration in central and eastern Europe, but also increasingly seeks to engage potential new markets in the emerging economies. During the latter part of 2011 a number of steps were taken to further this strategy, including some preliminary contacts with the United Arab Emirates that resulted in a number of senior Emirati officials participating in our leadership programmes. We also delivered a number of our educational and training programmes internationally, including the ongoing delivery of our MA in Leadership and Strategy to the senior public service in Lesotho.

The Institute, like many other public service organisations, is going through a significant period of change. Plans were agreed in 2011 for revised organisational arrangements and reduced staff numbers under the terms of the Croke Park Agreement. This process commenced towards the end of the year and will continue in 2012. The active engagement of staff and unions in this process was, and continues to be, critically important, and I wish to not only acknowledge their cooperation and support but also thank the Board and the various Board subcommittees for providing guidance on many of the above issues.

NATIONAL UNIVERSITY OF IRELAND AND UNIVERSITY COLLEGE DUBLIN ACCREDITED PROGRAMMES

From 2001 to 2011 the IPA was a recognised college of the NUI. In 2011 the IPA became a recognised college of UCD. The students who enrolled on education programmes in September 2011 will, in due course, receive UCD-accredited qualifications. Students who had enrolled in prior years will complete their qualifications under NUI accreditation.

Over the academic year 2010/2011, the Institute offered a suite of undergraduate and postgraduate programmes ranging from level 6 to level 9 of the National Framework of Qualifications. The conferring ceremony for NUI graduates took place on 6–7 December 2011 in Dublin Castle when 850 graduands were conferred.

UNDERGRADUATE PROGRAMMES

The flagship programmes – the BA (Hons) and the BBS (Hons) – were offered through three delivery methods: lectures at the IPA, lectures at regional centres and distance education.

In 2010/2011 seven specialisms were offered on the BA (Hons) and four on the BBS (Hons).

At diploma level, six specialisms were offered in the field of public management and four in business studies. Five special-purpose diplomas in European Union Studies, Health Economics, Human Resource Management, Law and Management were also offered in 2010/2011. The overall number of undergraduate students in 2011 was approximately 960.

POSTGRADUATE PROGRAMMES

The Institute's MA programmes have a common first year, for which there is an award of postgraduate diploma. In year two, students progress to a choice of six specialist areas. In 2011 the total number of students on MA programmes was approximately 185.

The MEconSc in Policy Analysis is a two-year programme with an award of postgraduate diploma at the end of the first year. Students study a range of policy-related subjects in the first year and they work in their departments on applied dissertations in the second year. In 2011 seventeen students enrolled on the programme and seven students graduated, having successfully completed the programme.

EDUCATION

The MSc in Business and Management is a new programme that commenced in September 2011. The MSc is a two-year, part-time programme and forty-five students were enrolled in the first intake.

The Professional Certificate in Governance commenced with its first intake of students in September 2011. The professional certificate is a one-year programme and twenty students were enrolled in the first intake.

The Doctorate in Governance programme commenced in 2003, and the first graduates were conferred in 2006. In 2011 approximately forty students were enrolled in the doctorate programme. Between 2003 and 2010 the Doctorate in Governance programme was jointly offered with Queen's University Belfast. In 2011 the Institute embarked on a new arrangement to jointly offer the programme with UCD. The new arrangement began in September 2011 with an enrolment of fourteen students.




RESEARCH

The IPA has a small, full-time, dedicated team of staff undertaking applied research for government departments and other public sector bodies.

The year 2011 saw the development of the IPA State of the Public Service research series, which started in 2010. This initiative tracks public service transformation and provides an evidence-informed perspective on public service change, facilitating key media contributions and other activities by the IPA. This is in line with the strategic objectives of developing an IPA ‘voice’ on key aspects of the transformation agenda, developing an IPA position on certain key aspects of transformation and building the IPA’s reputation as a source of public sector reform expertise. Under this series, four reports were published in 2011:

- Research Paper No. 3, *Organisational Capacity in the Irish Civil Service: An Examination of the Organisation Review Programme*, outlines lessons learned for both individual organisations and the civil service as a whole from experience to date in assessing organisational capacity;
- Research Paper No. 4, *Fit for Purpose? Challenges for Irish Public Administration and Priorities for Public Service Reform*, a major examination of public sector reform, identifies key challenges for the public service and suggests priority areas for change;
- Research Paper No. 5, *Better Use of Public Money*, examines the role of spending reviews and performance budgeting in reducing waste of public money;
- Research Paper No. 6, *Public Sector Trends 2011*, draws on national and international data on the performance, size and cost of public service, developing benchmarking data that can be used to raise public service performance and productivity issues.

A further report on workforce planning was near completion at the end of the year. The reports are available to download at http://www.ipa.ie/State_of_the_Public_Service_Series.



RESEARCH

The year also saw the introduction of a new research series focused on the needs of local government. The Local Government research series provides information on national and international experience with management reforms and highlights good practice. One report was published in 2011: Report No. 1, *Review of International Local Government Efficiency Reforms*, presents a brief overview of reforms undertaken in several jurisdictions designed to improve the efficiency of local government services. Two further reports, on strategic collaboration and on the impact of austerity on local governance, were nearing completion at the end of the year.

Other areas of research work undertaken in 2011 included:

- a report on university governance for the Irish Universities Association;
- international consultancy work with the Estonian State Chancellery on agency governance and reform;
- an independent external scrutiny of reports produced for the Organisational Review Programme, set up to examine the capacity of government departments and offices for the Department of Public Expenditure and Reform;
- work with two government departments on the development of performance indicators for their statements of strategy;
- running of the Certificate and Diploma in Civil Service and State Agency Studies;
- provision of administrative and report-writing support to committees established to progress local government reorganisation in Tipperary and Waterford;
- provision of two EU policy bulletins and two editions of *Local Authority Times* as part of an information service to local authorities throughout the year;
- academic publications in international journals and contributions to international books on public management;
- participation in international conferences, including work on the organising committee for the fifteenth annual International Research Society for Public Management conference, hosted by Trinity College Dublin and the University of Ulster.

TRAINING & DEVELOPMENT

The division had another successful year, with a sustained demand for relevant training and development programmes and other valued services. In addition to our advisory and support services, our externally accredited and professional body programmes attracted strong numbers and the diverse portfolio of conferences, seminars and workshop events scheduled throughout the year were also well attended.

The Leadership in Local Government Programme continues to attract a diverse group of high-potential candidates from a wide range of local authorities across Ireland. Cognisant of the current economic climate, the programme focused on delivering value to the organisation and the public through a challenging, practical and multidimensional approach. The Strategic Management Series also attracted strong numbers, with its emphasis on blended theory and practice to assist senior executives in the design and implementation of strategic management programmes in line with evolving public sector challenges.

Delivered in conjunction with Cambridge Leadership Associates, MA, incorporating senior faculty from the John F. Kennedy School of Government at Harvard, the Leadership Challenge Programme, aimed at senior public servants and designed to develop leadership capacity to support transformation and change in public administration, saw significant demand, with two programmes taking place. An evaluation of the programme in 2010 concluded that it is having a real impact on those who have participated, with clear evidence of changed behaviours and approaches.

The Governance Forum, now in its sixth year, continues to evolve and expand, and is recognised as providing a unique and important service through its particular emphasis on public and state bodies, public interest and public benefit organisations. A monthly programme of events combined core briefings on governance topics set in the context of issues that member organisations and senior management were facing. The diverse schedule of events covered many contemporary issues in governance, including *Good Governance in the Current Environment, Roles and Responsibilities of Board Members, Risk Management and Setting and Delivering Strategic Priorities*.

Round-table events brought together a broad network of individuals and peers to discuss the specific challenges of delivering key governance roles. A number of special events were also provided to members, including a programme on contemporary financial reporting issues and public financial procedures for board members, as well as a masterclass delivered by Harvard Professor Gary Orren on *Persuasion and the Achievement of Public Goals*.

In April our annual Governance Conference focused on the theme of *Good Governance - Setting the Tone from the Top* and included an address by Minister Brian Hayes, TD, and the Scottish Commissioner for Public Appointments, Karen Carlton. Part of the agenda examined the manner in which state board appointments are made, the importance of the culture of boards in setting the tone of an organisation and the skills and experiences required by governing bodies and board members.

The forum team also assisted many organisations with independent reviews of compliance with legal and regulatory governance obligations, implementation of risk-management systems, board-evaluation systems, competency assessments and related services.

In addition to the Governance Forum events, a series of breakfast seminars aimed at senior public sector managers was developed to address the key challenges facing the public service. In conjunction with the Local Government Directors Association, the IPA also developed a new series of masterclasses specifically for directors of services.

In December, to coincide with Budget 2012, a special budget seminar on the implications for public services and the economy more generally was arranged, and included contributions from Jim Power, economist; Deirdre Hanlon, Department of Public Expenditure and Reform; Derek Moran, Department of Finance; and Dr Richard Boyle, Head of Research at the IPA.

The Institute also organised a number of special conferences for the local government sector, where various groups had opportunities to listen to and discuss current policy and implementation issues. A recurring theme was the evolving statutory and other regulatory obligations on the sector across a wide range of the local authorities' mandate. Early in 2011 general election workshops were convened to incorporate updates on election arrangements, and the Legislative Training Programme continued to be in strong demand across the local authority sector throughout the year.

In addition to the NUI-accredited programmes, we continue to offer programmes for formal membership of professional bodies, including the Mediators' Institute of Ireland (MII), the Chartered Institute of Personnel Development (CIPD) and the Chartered Institute of Public Finance and Accountancy (CIPFA). Our established programme on workplace mediation, accredited by the MII, continued to attract strong numbers, the CIPD Foundation Level Certificate in HR Practice began its second run at the end of 2011, and a number of CIPD

certificate students continued their studies with the CIPD Foundation Level Diploma in HR Practice, which was launched this year.

Despite reductions in public sector training and development budgets, there continued to be a sustained demand for relevant and cost-effective services within the specialist areas of leadership and management, governance, finance, audit, information technology and human resource management. The CPD seminar series for public sector accountants and finance professionals, offered in conjunction with the professional accountancy bodies ACCA and CIPFA, experienced continued growth in 2011. IT training and education services, in conjunction with the School of Computer Science and Informatics, UCD, launched a second postgraduate qualification for non-computing graduates, the MSc in Computer Science by Negotiated Learning (MScNL) – Cloud Computing Stream. Both the MScNL and the original MSc in Computer Science programme have attracted national and international students. Services in areas such as virtualisation and cloud computing were also provided in addition to more traditional end-user training.

All certificate and diploma programmes continued to attract strong numbers. The Certificate in Public Procurement was supplemented by the commencement of a diploma that provides further learning pathways for students who successfully complete the certificate programme. The lectures and tutorials are delivered both centrally and in regional locations.

Consultancy included working with chief executives and senior teams from the statutory and voluntary sectors to prepare strategic plans for their organisations and conducting consultation processes with key stakeholders in relation to strategy development in voluntary organisations. On the international front, we continued to resource and deliver programmes such as provision of capacity building for an international public sector training agency, reviews of current strategies, and advice and guidelines to improve service delivery. This year we also collaborated with peer institutes across Europe on the delivery of blended learning programmes on EU financial management.

INTERNATIONAL SERVICES

In light of the ongoing domestic downturn, growing the potential of our international business has become a significant element of the Institute's strategy. In May a new international strategy was presented for discussion by the Board and subsequently agreed: this strategy seeks to continue and intensify our existing focus on capacity building/training in central and eastern Europe, but also to engage in developing new markets in emerging economies.

With the aim to adapt its structure to these new objectives, the Institute proceeded with the establishment of an International Implementation Group, tasked with reviewing, on a monthly basis, the status of our overseas work and making strategic and managerial decisions on work allocation and project delivery.


Intense tendering activity took place throughout the year, with no less than a dozen contract opportunities pursued, involving work for EU institutions, capacity-building programmes in Romania, Croatia, Macedonia and Kazakhstan, as well as support to sister institutions in Egypt and Tajikistan. Two opportunities have also been identified with the National Training Centre of the Hellenic Republic and the Regional School of Public Administration for the western Balkans (Montenegro); work with the latter was successfully delivered in the later part of the year and has led to new opportunities for 2012.

In addition, two study visits were organised in May and two international seminar/training events took place in Sofia and Bucharest in March and June. The EU Affairs programme, funded by the Department of Foreign Affairs since 2004, was completed in June with a structural fund seminar/training event in Romania, held in close collaboration with the Irish Embassy.

On the education front, new education programmes were delivered in Lesotho and enrolments in programmes in mainland China were confirmed.

The Institute continued to act in 2011 as the national contact point for twinning arrangements between Ireland and eastern, central and south-western Europe. It also took on a new role of national contact point for the EU Citizens programme, co-funded by the EU and the Department of Transport, Tourism and Sport.

Looking to new markets in emerging economies and further afield, a market-testing exercise, partly supported by Enterprise Ireland, was conducted in the Middle East region: initial contacts were made in Abu Dhabi with a



LIBRARY & INFORMATION SERVICES



LIBRARY & INFORMATION SERVICES

Supporting the Institute's education, training and research activities is the remit of the Library – a specialised public administration and public management resource extensively used by students, clients and staff. The Library provides an information, reference and lending service to a diverse and countrywide range of users, and has a comprehensive collection of material on a wide range of subjects, including law, economics, management, criminology, healthcare, finance and local government.

The Library in Lansdowne Road represents only a relatively small element of the Institute's Library Service. It also provides a telephone, postal and email service for distance-education students and members based outside the Dublin area. Students may, during term, contact Library staff or use the reading rooms from 9.15 a.m. until 8.30 p.m., Monday to Thursday, and until 5.30 p.m. on Friday. The Library is open on a restricted basis every Saturday and the majority of Sundays during term. Full and up-to-date information in relation to opening hours is available on the IPA website.


The Library contains just over 30,000 books, 150 hard-copy periodical titles, research studies, annual reports, reference sources and statistical data, and a considerable number of full-text journals are delivered electronically, together with full-text database-searching facilities.



The Institute's Book Publishing Committee had another productive year, overseeing the submission of a number of book proposals. Four main titles were published by the Institute during the course of 2011:


PUBLISHING CONSULTANCY

OUTREACH



OUTREACH

As noted in previous annual reports, the Institute is the body dedicated to the profession of public service. Consequently, the expertise of its staff is constantly called upon in ways other than the direct provision of services. From time to time, they also act in positions of leadership in the professional bodies to which they are attached. The Director General is a member of an informal network of heads of schools and institutes of public administration in the EU. During 2011 he was also a member of the adjudication panel for the Excellence in Local Government Awards, sponsored by the Chambers of Commerce of Ireland.

Dr Michael Mulreany, Assistant Director General, is a standing member of the Value for Money and Policy Review Group convened by the Department of Public Expenditure and Reform. Dr Richard Boyle is Chairman of the Irish Evaluation Network and a member of the international evaluation research group on policy and programme evaluation.

Five staff members are non-executive members of the audit committees of a number of government departments, local authorities and state-sponsored bodies; in two cases, acting as Chairman and Vice-Chairman of the committees. Several staff members play prominent officer roles in the Chartered Institute of Public Finance and Accountancy and the Chartered Institute of Management Accountants.



INSTITUTE GOVERNANCE AND ADMINISTRATION

The IPA, which is a company limited by guarantee, was incorporated in 1963. It operates under the aegis of the Department of Public Expenditure and Reform, is a not-for-profit organisation with registered charity status and is subject to statutory audit by the Comptroller and Auditor General. It is also designated a non-commercial state agency.

It is governed by a Board – under the current chairmanship of John Tierney – comprising elected/nominated representatives of various public administration sectors, Institute management and staff, the academic world and trade union personnel, together with a student representative. The Board operates through its scheduled monthly meetings and three standing Board subcommittees: the Finance and Strategy Committee, which deals with strategic financial management issues, including capital works; the Administration Committee, which monitors day-to-day operating performance, human resource issues, etc.; and the Audit Committee, which deals with risk assessment and governance matters. In addition, there is an Education Committee, which advises on and monitors educational qualifications and courses, and a Book Publishing Committee, which advises on publications strategy.

The Institute President presides at the annual general meeting (AGM) and has the support of a number of vice-presidents. The 48th AGM of the Institute took place on 29 June 2011. The names of the honorary officers, Board members and Board subcommittee members are contained on the inside front cover of this annual report.

REPORT OF THE CHAIRMAN OF THE ADMINISTRATION COMMITTEE

Donal Connell reports:

The committee met twice during 2011. In accordance with the *Code of Practice for the Governance of State Bodies*, a review of the Board was undertaken during 2011. As part of the review a questionnaire was issued to all Board members. The Administration Committee considered the responses to the questionnaire and made recommendations to the Board in terms of the composition and size of the Board, the strategic operation of the Board and risk management. The committee advised the Board on the Institute change management programme, including the redeployment and organisation redesign programme.

REPORT OF THE CHAIRMAN OF THE AUDIT COMMITTEE

Raymond Dolan reports:

The committee met twice during 2011. It carried out its role of supporting the Board in meeting its corporate governance responsibilities. Activities during the year included reviewing the annual financial statements, internal financial controls and the corporate risk register; overseeing the internal auditor's programme; and ensuring compliance with all other relevant obligations. It also liaised with the representative of the Institute's auditors – the Comptroller and Auditor General.

REPORT OF THE CHAIRMAN OF THE FINANCE AND STRATEGY COMMITTEE

John Tierney reports:

The committee met on six occasions during the year. With the ongoing difficult economic trading environment generally, the main business transacted was to monitor the Institute's monthly financial and cash flow reports to ensure that they were performing as planned. The committee also approved the 2011 budget and, on behalf of the Board, reviewed the quarterly management accounts and financial forecasts. As stated above, given the continued difficult trading conditions for the IPA in 2011, the committee placed a particular emphasis on this work.

The committee also advised the Board on a number of key strategic issues that arose during the year, including reviewing performance against the 2011 corporate business plan. It continued to monitor the development works at the IPA's Lansdowne Road campus, principally No. 55, which culminated in the transfer of staff from the Clonskeagh office in May 2011, thereby achieving a key strategic objective of consolidating the Institute's activities onto one campus.

On behalf of the Board, the committee also considered and approved the Institute's 2011-2015 corporate strategy, which included a new international business strategy. As part of its deliberations on the strategy, the committee also examined a number of multi-annual budget scenarios for the period of the plan. Based on this analysis, the committee recommended to the Board that the Institute should continue with its cost-reduction programme, encompassing the redeployment option as set out in the Croke Park Agreement. The committee also maintained a watching brief of the Institute's pension scheme with its new public sector remit.

INSTITUTE GOVERNANCE & ADMINISTRATION

MEMBERSHIP

The Institute is the professional body for public servants. It caters for those in the civil service, local authorities, health service, state-sponsored bodies, education sector, Garda Síochána and the defence forces. Members are kept abreast of current public management issues through access to special briefings, an e-newsletter and the journal *Administration*, and enjoy discounts on publications and other services. Members are consulted on current public management issues and future IPA service provision, and thereby contribute to the professional development of the Institute. There are currently 69 corporate members of the Institute and 1,800 individual members, incorporating both students and interested members of the general public.


HUMAN RESOURCES MANAGEMENT

During 2011, as part of the implementation of the 2011-2015 corporate strategy, an Organisation Design Group, representative of all grades and business units, was established to consider appropriate organisational arrangements, including organisation design and allocation of staffing, that would best support the delivery of the new strategy. The Board approved a revised organisation structure with revised staff numbers based on business activity in each of the business units. This plan will be implemented in 2012.

During the year staff were supported in attending various third-level and other development programmes. Also, a series of monthly staff meetings was organised to provide updates on various internal and external developments.

A review of staff competencies was also undertaken, and this will be refined in the context of the proposed reorganisation of structures. The new alliance with UCD afforded opportunities for some joint development activities and other initiatives, which included IPA staff attending development workshops in UCD and UCD staff attending IPA courses. It is planned to further intensify this type of collaboration in coming years.

FINANCIAL PERFORMANCE



FINANCIAL PERFORMANCE

The Financial Statements that follow set out in detail the financial operation of the Institute for the year. The ongoing trading difficulties in the Irish economy, and the related contraction in government spending, continued to impact on the Institute's operating income during 2011. Compared with 2010, operating income was down at €12.2m from €13.0m, a decrease of 6%. However, as the IPA foresaw the potential impact on its 2011 turnover, it took the necessary steps to reduce both its pay and non-pay costs. The impact of this work was to reduce expenditure to €12.1m, compared to €12.6m for 2010, representing a decrease of the order of 4%. For the first time since the introduction of the pension accounting standard (FRS17) in 2005, there has been no actuarial adjustment of the IPA's pension costs in the income statement. In summary, the Institute continued to stabilise its finances during this ongoing difficult economic period.



The Institute's earnings were made up of training and international services (37%), education-fee income (31%), research income (2%), publications and membership income (6%) and a grant-in-aid (24%) paid by the Department of Public Expenditure and Reform. Overall, year-on-year decreases in income are directly related to decreases in levels of activity in a more uncertain trading environment. The IPA's cost structure, on the other hand, was primarily governed by direct and indirect costs (which decreased in line with lower income and successful value-for-money reviews), salary costs and debt-servicing costs. Salary costs were governed by three factors: namely, the number of permanent staff employed, the payment of staff salary increments (per the Croke Park Agreement) and the Institute's obligations to the staff defined-benefit pension scheme. With the public sector moratorium on staff recruitment, the Institute's staff numbers decreased slightly to 98 (from 99) in 2011, and the level of employer pension contribution continues as before (at 34.6% of salaries) following the fund transfer to the National Pension Reserve Fund (NPRF), thus leaving the payment of salary increments as the main contributor to slightly higher salary costs. In the matter of the transfer of the IPA's pension fund to the NPRF, the accounting treatment of pension contributions is reflected in the Financial Statements as a 'contribution to the Exchequer'.


The financing costs for the long-term loan facility used in the purchase of No. 55, Lansdowne Road (acquired in mid 2006), are based on inter-bank interest rates, which were also eased during 2011, resulting in a full-year interest charge of €64,143. The IPA completed a refurbishment of No. 55 during 2011, which culminated in the transfer of staff from the Clonskeagh office in May 2011, thereby achieving a key strategic objective of consolidating the Institute's activities onto one campus.

FINANCIAL PERFORMANCE

In overall financial management terms, given the ongoing straitened trading conditions, the Institute continued to stabilise its finances during 2011 with a small operating surplus achieved. In addition, the IPA's Balance Sheet reserves have also recovered positively to pre-2005 values.

INTERNAL SYSTEMS ENHANCEMENTS

In line with the Institute's information systems strategy, there were further developments in the internal IT hardware and software infrastructure. The quality of the IPA's financial management system (FMS) continues as a key support for the Institute to prepare accurate forecasts and to manage the levelling off in income levels. Internal management systems were further developed during the year, with enhanced management information system reporting facilities from the IPA's FMS being made available across the IPA, financial awareness sessions held for all staff and the embedding of the FMS business performance module. The focus on good-quality management information reporting will be a key focus during 2012.



FINANCIAL PROSPECTS FOR 2012

Given that the ongoing difficult economic trading conditions for all businesses are expected to continue until at least 2014, the Institute is focusing on maintaining a relatively stable set of finances for 2012. Turnover is expected to stabilise at €12m with a break-even budget. The IPA continues to look for new opportunities to sustain its income base (such as the collaboration with UCD) and to reduce both its pay and non-pay cost structures. The success of the process of redeployment will be key to the Institute's success in achieving its 2012 budget targets.

COMPLIANCE

The Institute complied with its financial, taxation and regulatory obligations during 2011, and continued to review and update its corporate governance structures.

REPORT OF THE DIRECTORS IN RESPECT OF THE YEAR ENDED 31 DECEMBER 2011

STATEMENT OF DIRECTORS' RESPONSIBILITIES

- 1.** Company law requires the directors to prepare Financial Statements for each financial year that give a true and fair view of the state of affairs of the company and of the surplus of the company for that period. In preparing those Financial Statements, the directors are required to:
- select suitable accounting policies and then apply them consistently;
 - make judgements and estimates that are reasonable and prudent;
 - state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the Financial Statements;

On behalf of the Board, management carry out an annual review of business operational risks.

RESEARCH AND DEVELOPMENT

- 7.** The company is not involved in any research and development on its own behalf.

PROPER BOOKS OF ACCOUNT

- 8.** In order to ensure that proper books of account are kept in accordance with Section 202 of the Companies Act, 1990, appropriately qualified personnel are employed and appropriate resources are made available to the company's finance function. The books of account are located at the company's registered office at 59 Lansdowne Road, Dublin 4.

AUDITORS

- 9.** In accordance with Section 5 of the Comptroller and Auditor General (Amendment) Act, 1993, the Comptroller and Auditor General is responsible for the audit of the company's accounts.

INSTITUTE OF PUBLIC ADMINISTRATION

I have audited the Financial Statements of the Institute of Public Administration for the year ended 31 December 2011 under the Comptroller and Auditor General (Amendment) Act, 1993. The Financial Statements, which have been prepared under the accounting policies set out therein, comprise the Statement of Accounting Policies, the Statement of Income and Expenditure, the Statement of Total Recognised Gains and Losses, the Balance Sheet, the Cash Flow Statement and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and Generally Accepted Accounting Practice in Ireland.

RESPONSIBILITIES OF THE DIRECTORS

The directors are responsible for the preparation of the Financial Statements, for ensuring that they give a true and fair view of the state of the company's affairs and of its income and expenditure, and for ensuring the regularity of transactions.

RESPONSIBILITIES OF THE COMPTROLLER AND AUDITOR GENERAL

My responsibility is to audit the Financial Statements and report on them in accordance with applicable law.

My audit is conducted by reference to the special considerations which attach to state bodies in relation to their management and operation.

STATEMENT ON INTERNAL FINANCIAL CONTROL

The Board acknowledges its responsibility for the Institute of Public Administration's system of financial control. It also recognises that any system of financial control can only give a reasonable and not absolute assurance against any material errors. The internal financial controls in operation within the Institute during 2011 are outlined in the following.

The key procedures, which have been put in place by the Board, designed to provide effective financial control are:

(A) CONTROL ENVIRONMENT

The Board has taken steps to ensure an appropriate control environment is in place by:

- establishing formal procedures through various committee functions to monitor the activities and safeguard the assets of the organisation;
- clearly defining and documenting management responsibilities and powers;
- developing a strong culture of accountability across all levels of the organisation.

All staff members have been supplied with financial control procedures, including procurement, and debtor and creditor procedures.

Expenditure limits are applied rigorously to all levels of management. This control is monitored by the Institute's Finance Office by way of both manual and electronic automated checks.

There is consistent separation of function for coding and authorisation operated across the Institute's business units and monitored centrally by the Finance Office.

The procurement function for overhead expenditure operates on the basis of standards agreed with the Director of Finance and Support Services and approved by the Director General and the Board.

(B) IDENTIFICATION OF BUSINESS RISKS AND FINANCIAL IMPLICATIONS

In line with the IPA's annual processes, a business risk review was carried out during the year, involving the senior management group, highlighting the

significant risks to the IPA's business with related necessary mitigating actions. The business risks identified in the review are being addressed, in the first instance, through the implementation of the Institute's corporate plan (corporate-level risk register), and then through the business planning process. For 2012, each business division will again be embedding their risk-mitigation activities in their annual business plans. These business plans and the risk-management activities are discussed by the Board on a half-yearly basis.

(C) INFORMATION SYSTEMS

The Institute's information systems include an integrated financial and management accounting package, 'Integra'. There are integrated electronic financial control modules for income, expenditure, debtors, creditors, purchase ordering, payroll, staff travel and subsistence, and fixed assets on the system. Most of the information processing controls are automated within the electronic systems; the controls include proper authorisation, segregation of duties and scanning of original documentation and records. There is a full suite of control procedures governing the Institute's information processing.

In addition, there are a number of business support systems integrated into the financial management system (FMS). The IPA's Publication Division operates a Sales Order Processing (SOP) module, catering for the sales ordering, invoicing and stock control. The Training Division uses an integrated Training Administration and Management System (TAMS) to manage the client booking and invoicing process. For our Education programmes, an integrated Student Information and Administration System (SIAS) manages student registration and fee collection.

(D) PROCEDURES FOR MONITORING EFFECTIVENESS OF FINANCIAL CONTROL SYSTEM

Monthly management accounts are prepared comparing budgeted income and expenditure with that actually incurred. The senior management group reviews these accounts, involving a detailed examination of the underlying transactions and activities to ensure completeness and accuracy.

STATEMENT ON INTERNAL FINANCIAL CONTROL

These accounts are put before the Board on a quarterly basis.

The annual budgetary process is extensive whereby each unit produces a detailed income and direct expenditure budget, which is reviewed and approved by the Board. Detailed capital expenditure budgets are also prepared. In addition, the Institute operates a three-year rolling system of multi-annual budgeting.

The Institute has an internal audit function that is currently outsourced. A detailed audit programme is prepared annually and approved by the Board through its Audit Committee. The internal audit plan is reviewed on an ongoing basis. The Audit Committee reviews the audit reports prepared, including the implementation of recommendations.

The Institute's Finance Office monitors income and expenditure transactions to ensure compliance by each of the business units for accuracy, validity and appropriateness.

(E) ANNUAL REVIEW

An annual review of the Institute's internal financial controls in operation during 2011 was carried out. The Institute's Board reviewed the effectiveness of the internal financial control systems at its meeting on 9 February 2012.

STATEMENT OF ACCOUNTING POLICIES

The Financial Statements are prepared in accordance with the historical cost convention as modified by the revaluation of land and buildings.

(A) INCOME

Income, comprising mainly fees and the state grant-in-aid, is included on a receivable basis with the exception of subscriptions, which are taken into income when received. Course fees are taken into the Statement of Income and Expenditure during the period of the course.

(B) FIXED ASSETS AND DEPRECIATION

Fixed assets, including buildings, are stated at their historical cost or valuation less accumulated depreciation. Depreciation is provided on the basis and rates stated below, which are estimated to reduce the assets to realisable values by the end of their expected working lives:

Freehold Buildings	2% Straight Line
Leasehold Premises	2% Straight Line
Furniture and Fittings	5% Straight Line
Equipment	10% Straight Line
Library Books	20% Reducing Balance
Office Machines	25% Straight Line
Leased Assets	33.3% Straight Line
Prefabricated Buildings	33.3% Straight Line

Depreciation commences in the year in which the asset is brought into use. Land is not depreciated. The Institute has not adopted a policy of revaluation; however, certain assets were revalued prior to the adoption of Financial Reporting Standard 15 'Tangible Fixed Assets'. In accordance with the provisions of the standard, the Institute has retained these valuations as set out in Note 9.

(C) STOCKS

Stocks have been valued consistently with prior years, at the lower of cost and net realisable value. Provision is made, where necessary, for obsolete and slow-moving stock.

(D) DEBTORS

Known bad debts are written off and specific provision is made for any amounts the collection of which is considered doubtful.

(E) CAPITAL GRANTS

Capital grants relating to fixed assets are treated as deferred credits and are amortised in the Statement of Income and Expenditure over the expected useful life of the assets.

(F) LEASED ASSETS

Assets held under finance leases are capitalised and included with similar owned assets in the Balance Sheet. Obligations under finance leases are included with liabilities, analysed between current liabilities and long-term liabilities. Payments made under operating leases are charged to the Statement of Income and Expenditure.

(G) PENSION COSTS

A defined-benefit pension scheme is in place for all employees of the Institute of Public Administration, as appropriate. Under the provisions of the Financial Measures (Miscellaneous Provisions) Act, 2009, the Institute's pension fund assets, which were measured at fair value, transferred to the National Pension Reserve Fund (NPRF) on 30 June 2010. The pension scheme continues in force for existing members with no impact on benefits or associated provision for members.

For the period to 30 June 2010, the scheme was funded by contributions (from the Institute and employees), which were transferred to a separate trustee administered fund net of pensioner payments and scheme expenses. From 1 July 2010, the Institute became responsible for the administration of the pension payments to pensioners on behalf of the Exchequer. Under the new arrangement the Institute's funding contribution will continue in being and is payable to the Department of Public Expenditure and Reform after taking account of pensions paid. The department will provide funding where the pensions paid exceed the contribution.

STATEMENT OF ACCOUNTING POLICIES

Pension scheme liabilities are measured on an actuarial basis using the projected unit method, and represent the present value of future pension payments earned by staff to date. In line with the pension funding arrangements, an asset equal in amount to this liability is recognised and represents the amounts to be reimbursed in future periods by way of Oireachtas grant.

The pension charge in the Income and Expenditure Account comprises the current service cost and past service cost plus the difference between the expected return on scheme assets and the interest cost on the scheme liabilities up to the date of transfer of the pension fund assets, and the Institute's contribution payable to the Department of Public Expenditure and Reform from the date of transfer in line with the funding arrangements.

Actuarial gains and losses arising from changes in actuarial assumptions and from experience surpluses and deficits up to the date of transfer are recognised in the Statement of Total Recognised Gains and Losses for the year in which they occur.



The Institute's Balance Sheet reserves comprise a capital reserve, a revenue reserve and an accumulative surplus reserve on income and expenditure. The capital reserve is held to fund the development of the IPA's building infrastructure, the revenue reserve caters for the principal on the long-term mortgage debt facility, while the accumulative surplus reserve is used to fund ongoing operating activities.

15. PENSIONS

(a) Pension Liability and Asset

As outlined in Accounting Policy (g) above, the Institute's pension fund was transferred to the National Pension Reserve Fund (NPRF) on 30 June 2010 in accordance with the Financial Measures (Miscellaneous Provisions) Act, 2009. Following the transfer of scheme assets, the Institute is required to pay the Department of Public Expenditure and Reform an annual contribution after taking account of pensions due for payment. The department will provide funding where the pensions paid exceed the contribution. The Board has adapted the treatment and disclosures required by the accounting standard Financial Reporting Standard 17 (Retirement Benefits) to reflect the arrangements in operation. While the funding arrangement operates on a net pay over basis with the department, the Institute believes the nature of the arrangement is akin to a full reimbursement of the pension liability when those liabilities fall due for payment, and therefore recognises its right to the reimbursement as a separate asset in an amount equal to the liability at the year-end.

The FRS 17 pension liability at 31 December 2011 is €40,433,000 (2010: €38,374,000) based on an actuarial valuation of the pension liabilities in respect of Institute staff as at 31 December 2011, carried out by a qualified independent actuary for the purposes of FRS 17. A deferred funding asset of €40,433,000 equal to the liability at 31 December 2011 is recognised as a separate asset on the Balance Sheet.

With the transfer of the fund assets to the NPRF in 2010, there is no pension cost recognised in the Statement of Income and Expenditure for 2011 (2010: €640,000).

(c) Contribution to the Exchequer

In accordance with the Financial Measures (Miscellaneous Provisions) Act, 2009, and the arrangements set out in note (a) above, contributions payable to the Exchequer by the Institute from surplus revenue available to it amounted to €1.804m in the period 1 January to 31 December 2011. The Institute made pension and other payments of €1.77m on behalf of the Department of Public Expenditure and Reform after taking account of employee contributions of €115,904. The amount payable to the department at year-end amounted to €150,620.

(d) Description of Scheme and Actuarial Assumptions

The pension scheme is a defined-benefit final salary pension arrangement with benefits defined by reference to current public sector scheme regulations. The scheme provides a pension (in eightieths per year of service), a gratuity or lump sum (at three-eightieths per year of service) and spouse's and children's pension. Normal retirement age is a member's 65th birthday. Pensions in payment (and deferment) normally increase in line with general public sector salary inflation. The current practice of increasing pensions in line with public sector salary inflation is taken into account in measuring the defined-benefit obligation.

Bliain an-chrua a bhí inti arís ina raibh go leor dúshlán le sárú againn agus an próiseas coigeartaithé atá riachtanach faoi théarmaí an chláir tacaíochta airgeadais d'Éirinn ag bailiú nirt, rud a raibh impleachtaí suntasacha aige do sheirbhís phoiblí na hÉireann. Tá sé ar cheann de na príomhcheanglais a bhaineann leis an glár tacaíochta airgeadais €85 billiún d'Éirinn atá á maoiriú ag an AE, ag an gCiste Airgeadaíochta Idirnáisiúnta agus ag an mBanc Ceannais Eorpach go ndéanfar laghdú mór ar chostas na seirbhise poiblí.

I rith na bliana leanadh den phróiseas chun an fhoireann a laghdú ar fud na seirbhise poiblí agus cuireadh dlús leis. Bhíothas ag súil go mbeadh 9,000 ball foirne breise tar éis an tseirbhís phoiblí a fhágáil faoi thús na bliana 2012. Laghdaíodh líon na mball foirne ar fud na n-earnálacha ar fad – an státseirbhís, an tseirbhís sláinte, na húdaráis áitiúla, na fórsaí cosanta agus an Garda Síochána.

Fágann sé sin freisin go mbeidh ar an tseirbhís phoiblí teacht ar bhealaí nua oibre, ina mbeidh siad ar thús cadhnaíochta, ag comhoibriú agus ag pleánaíl ar mhaithe le hacmhainní ganna – go háirithe acmhainní foirne – a úsáid ar bhealach chomh héifeachtúil agus is féidir. Bhí na dúshláin sin mar bhonn ag an *bPlean um Athchóiriú na Seirbhise Poiblí* a d'fhoilsigh an Roinn Caiteachais Phoiblí agus Athchóirithe i Samhain 2011. Bhí sraith spriocanna sa phlean sin a bhí ina ndúshláin do gach earnáil.

Sa chomhthéacs sin, lean an Foras de ról ríthábhachtach ó thaobh deiseanna plé agus díospóireachta a chur ar fáil faoi na roghanna agus na dúshláin atá roimh an tseirbhís phoiblí. Go deimhin, ba é téama ár gcomhdhála bliantúla in 2011 ag a labhair Brendan Howlin, TD, an tAire Caiteachais Phoiblí agus Athchóirithe ná *Next Stages in Public Service Reform – Challenges and Choices*. Tugann Fóram Ríalachais an Fhorais Riaracháin deis freisin do bainisteoiri sinsearacha eolas cothrom le dáta a fháil faoin dea-chleachtas ríalachais agus bainistíochta, agus tá sé níos tábhactaí ardchaighdeáin ríalachais a choimeád ar bun tráth a bhfuil cúrsai ag athrú go tobann agus ag corraí sa chóras. Labhair an tAire Brian Hayes, TD ag an gComhdháil Ríalachais a bhí bunaithe ar an téama *Setting the Tone from the Top*.

Bíonn géarghá le ceannaireacht le linn athraithe, agus lean an Foras Riaracháin de chláir cheannaireachta a sholáthar le haghaidh fostaithe sinsearacha sa tseirbhís phoiblí ar fud an chórais i rith na bliana. Tacaíonn na cláir seo le bainisteoí agus iad ag iarráidh réitigh ar na dúshláin atá le sárú acu a shamhlú, ach tacáíonn siad leo freisin chun idirghabhálacha a cheapadh lena mbainfear amach na spriocanna maidir le hathrú atá leagtha amach faoin bplean um athchóiriú. Tá an Foras Riaracháin fós den tuairim gur chóir tú sáite a thabhairt

d'fhorbairt na hacmhainne ceannaireachta laistigh den tseirbhís phoiblí, go háirithe nuair atá athruithe suntasacha ag teacht ar phearsanra ar an leibhéal sinsearach, rud a dtagraítear thuas dó.

Sheol an Foras a straitéis nua don tréimhse 2011-2015 in 2011 freisin. Bunaíodh an Foras ar dtús chun caighdeán ghairmiúla seirbhíse poiblí a fhorbairt agus a fheabhsú, agus tá an sprioc sin fós mar phríomh-mhisean ag an bhForas. Mar sin, sa straitéis nua tá béisim á leagan ar fhorbairt caighdeán gairmiúil trí oideachas agus trí thaighde acadúil agus ar fhorbairt phraiticiúil i réimsí amhail ceannaireacht, bainistíocht, rialachas, bainistíocht airgeadais, bainistíocht acmhainní daonna agus teicneolaíocht faisnéise. Beidh forbairt bhreise acmhainne sna réimsí seo ar fad ríthábhachtach ó thaobh na spriocanna sa *Phlean um Athchóiriú na Seirbhíse Poiblí* a bhaint amach.

Ó thaobh caighdeáin ghairmiúla a shaothrú, d'fhógair an Foras freisin go mbunófaí comhghuaillíocht straitéiseach fhoirmiúil leis an gColáiste Ollscoile, Baile Átha Cliath (COBÁC) in 2011, agus san fhómhar, tháinig an Foras Riaracháin chun bheith ina choláiste aitheanta de chuid COBÁC. Fágann sé seo go mbeidh rochtain ag fostaithe sa tseirbhís phoiblí ar na deiseanna dul chun cinn agus aistrithe a bhaineann le bheith nasctha le hollscoil mhór dá leithéid a bhfuil cáil uirthi ar fud an domhain agus raon leathan clár agus cúrsaí á dtairiscint aici. Ina theannta sin, trí bheith nasctha le próiseas creidiúnaithe COBÁC, beidh dearbhú ag ár mic léinn faoi sheasamh idirnáisiúnta agus faoi chaighdeán na gcáilíochtaí a fhaigheann siad. Tá an chéad chlár á thairiscint ag an bhForas Riaracháin i gcomhar le COBÁC cheana féin, an cháilíocht is airde atá á tairiscint ag an bhForas, an Dochtúireacht sa Rialachas.

Tá súil againn go mbainfidh ár mic léinn reatha agus mic léinn amach anseo leas as an gcomhghuaillíocht nua, ionas gur fearr a bheimid in ann na spriocanna seo a spreag bunaitheoirí an Fhorais a shaothrú, spreagadh intleachtúil a chur ar fáil, ardchaighdeán seirbhíse poiblí a chur chun cinn agus naisc idirnáisiúnta a fhorbairt. 

Bliain chrua a bhí sa bhliain 2011 arís do sheirbhís phoiblí na hÉireann, agus b'iomaí dúshlán a bhí le sárú ag an bhForas. De bharr na gciorruiithe leanúnacha sa chaiteachas poiblí, tháinig laghdú breise ar bhuiséid le haghaidh oiliúna, oideachais, taighde, agus seirbhísí eile a chuireann an Foras ar fáil. In ainneoin na ndúshlán sin, rinneadh dul chun cinn maidir le roinnt réimsí, go háirithe cur chun feidhme straitéis an Fhorais le haghaidh 2011-2015, dar teideal, *Professional Development and Public Service Renewal*, a seoladh ag túis na bliana.

Cé gur laghdaíodh tuilleadh ioncaim ó tháillí ar sheirbhísí agus deontas i gcabhair ón Státhiste, tá clár mór laghdaithe costais curtha i bhfeidhm ag an bhForas, agus chabhraigh laghduithe breise ar thuarastail agus ar chostais eile i rith na bliana le toradh airgeadais sásúil a bhaint amach faoi dheireadh na bliana. D'éirigh leis an bhForas a chúrsaí airgeadais a chobhsú le dhá bhliain anuas agus tá dul chun cinn á dhéanamh le pleannanna chun cúrsaí airgeadais agus eagraíochtúla an Fhorais a dhaingniú tuilleadh.

Sa réamhrá ar ár straitéis nua, leagamar béis faoi leith ar fhorbairt ghairmiúil fostaithe sa tseirbhís phoiblí mar rud atá riachtanach le taca a chur faoi athnuachan agus forbairt ár seirbhíse poiblí. Tá ról ríthábhachtach ag an oideachas agus ag taighde ó thaobh forbairt ghairmiúil. Maidir leis seo rinneadh fiordhul chun cinn le linn 2011 chun forbairt bhreise a dhéanamh ar chláir agus ar sheirbhísí Scoil Whitaker um Rialtas agus Bainistíocht de chuid an Fhorais Riarachán. Tugadh isteach MSc nua i Staidéar Gnó, mar aon le Teastas nua Gairmiúil i Rialachas agus Teastas i dTithíocht. Leanamar ar aghaidh leis an tsraith taighde faoi Staid na Seirbhíse Poiblí. Rinneadh athbhreithniú mór ar na príomh dhúshláin i riachán poiblí na hÉireann, dar teideal *Fit for Purpose?* mar chuid den tsraith agus foilsíodh i mí Aibreáin é. Tá an tuarascáil *Public Sector Trends 2011*, a foilsíodh i mí na Samhna, mar chuid de shraith ina gcuirtear caighdeán cháilíochta, éifeachtúlachta agus feidhmíochta earnáil phoiblí na hÉireann i gcomparáid le caighdeán tíortha eile, agus is bonn fianaise tábhachtach é chun eolas a chur ar fáil don díospóireacht agus don phlé faoin ábhar tábhachtach seo. Thugamar isteach sraith taighde nua faoin rialtas áitiúil in 2011 freisin, a seoladh le páipéar ar an *Review of International Local Government Efficiency Reforms*.

I rith 2011, mar chuid de chur chun feidhme straitéis chorparáideach 2011-2015, bunaíodh Grúpa Deartha Eagrúcháin, atá ionadaíoch ar na gráid agus ar na haonaid ghnó go léir chun breithniú a dhéanamh ar na socruithe eagrúcháin iomchuí, lena n-áirítear dearadh eagrúcháin agus dáileadh an tsoláthair foirne, a bheadh ar an tacá is fearr chun an straitéis nua a chur i gcrích. D'fhaomh an Bord struchtúr eagrúcháin athbhreithnithe lena mbaineann lón leasaithe na foirne bunaithe ar an gníomhaíocht ghnó i ngach ceann de na haonaid ghnó. Cuirfear an pleán sin i bhfeidhm in 2012.

I rith na bliana tugadh tacaíocht don fhoireann freastal ar chláir éagsúla tríú leibhéal agus forbartha eile. Ina theannta sin, eagraíodh sraith cruinnithe foirne míosúla chun nuashonruithe a chur ar fáil ar fhorbairtí inmhéánacha agus seachtracha éagsúla.

Rinneadh athbhreithniú ar inniúlachtaí na foirne freisin, agus déanfar é sin a scagadh i gcomhthéacs atheagrú molta na struchtúr. Chuir an chomhghuaillíocht nua le COBÁC roinnt deiseanna ar fáil le haghaidh roinnt gníomhaíochtaí compháirteacha agus le haghaidh tionscnamh eile, lenar n-áiríodh fhoireann an Fhorais Riaracháin a d'fhreastail ar cheardlanna forbartha i gCOBÁC mar aon le fhoireann na hOllscoile féin a d'fhreastail ar chúrsaí an Fhorais Riaracháin. Leagtar amach sna ráitis airgeadais seo a leanas oibríocht airgeadais an Fhorais i leith na bliana. Lean na deacrachaí trádála i ngeilleagar na hÉireann, agus an cálú i gcaiteachas an rialtais, ag dul i bhfeidhm ar ioncam oibriúcháin an Fhorais i rith 2011. I gcomparáid le 2010, bhí an t-ioncam oibriúcháin níos lú agus €12.2m ann síos ó €13.0m, laghdú 6%. Mar sin féin, bhí a fhios ag an bhForas cheana féin go mbeadh tionchar ar a láimhdeachas i rith 2011, ghlac sé leis na céimeanna riachtanacha chun a chostais phá agus neamh-phá a laghdú. Ba é tionchar na hoibre seo caiteachas a laghdú go €12.1m i gcomparáid le €12.6m le haghaidh 2010, ag léiriú laghdaithe thart ar 4%. Den chéad uair ó tugadh isteach an caighdeán cuntasaíochta pinsin (FRS17) in 2005, ní raibh coigearnácht achtúireach i ndáil le costais phinsin an Fhorais sa ráiteas ioncaim. Go hachomair, lean an Foras ar aghaidh ag cobhsú a chuid airgeadais i rith na tréimhse deacra eacnamaíochta seo a lean sa tír.




Bhí tuillimh an Fhorais comhchéanta de sheirbhísí oliúna agus idirnáisiúnta (37%) agus ioncam ó tháillí oideachais (31%), ioncam ó thaighde (2%), ioncam ó fhoilseacháin agus ó bhallaíocht (6%), agus deontas i gcabhair (24%) arna íoc ag an Roinn Caiteachais Phoiblí agus Athchóirithe. Ar an iomlán, bíonn gaol díreach ag laghduithe ioncaim bliain i ndiaidh bliana ar leibhéal ghníomhaíochta i dtimpeallacht trádála atá níos éiginnte. Ar an taobh eile, bhí struchtúr costais an Fhorais Riarachán faoi smacht ag costais dhíreacha agus indíreacha (a laghdaíodh i gcomhréir le hioncam laghdaithe agus athbhreithnithe luach ar airgead a bhí rathúil), costais tuarastail agus seirbhísíú fiachais. Rinne an Foras Riarachán athchóiriú ar Uimh. 55 i rith 2011, as a dtáinig aistriú forne ó Oifig Chluain Sceach i mBealtaine 2011

I dtéarmaí foriomlána bainistíochta airgeadais, nuair a thógtar san áireamh na coinníollacha deacra trádála a lean sa tír, lean an Foras ag cobhsú a chuid airgeadais le linn 2011 i slí a d'fhág barrachas beag oibriúcháin mar thoradh. Anuas air sin, tháinig biseach ar chúlchistí an Fhorais Riarachán ar an gClár Comhardaithe go dtí luachanna a bhí ann roimh 2005.

Admhaíonn an Bord go bhfuil sé freagrach as córas rialithe airgeadais an Fhorais Riaracháin. Is iad seo a leanas na príomhnósanna imeachta a chuir an Bord i bhfeidhm agus tá siad deartha chun rialú airgeadais éifeachtach a sholáthar:

(A) TIMPEALLAHTH RIALAITHE

Is iad seo na bearta atá déanta ag an mBord le cinntiú go bhfuil timpeallacht chuí rialála i bhfeidhm:

- nósannaimeachta foirmiúla a bhunú, trí bhíthin feidhmeanna éagsúla coiste, le monatóireacht a dhéanamh ar ghníomhaíochtaí agus le sócmhainní na heagraíochta a chosaint;
- freagrachtaí agus cumhactaí an lucht bainistíochta a shainiú agus a dhoiciméadú go soiléir;
- cultúr láidir cuntasachta a fhorbairt ar gach leibhéal den eagraíochta.

Tá nósannaimeachta rialithe airgeadais curtha ar fáil do gach ball forne, lena n-áirítear nósannaimeachta soláthair, agus na nósannaimeachta maidir le féichiúnaithe agus creidiúnaithe.

Cuirtear teorainneacha caiteachais i bhfeidhm go dochtaidir le gach leibhéal bainistíocha. Déanann Oifig Airgeadais an Fhorais monatóireacht ar an rialú seo, trí scrúduithe láimhe agus trí scrúduithe uathoibrithe leictreona.

Tá scardh comhsheasmhach curtha i bhfeidhm maidir le feidhmeanna códaithe agus údaraithe ar fud aonad gnó an Fhorais agus déanann an Oifig Airgeadais monatóireacht lárnach air.

Oibríonn an fheidhm soláthair le haghaidh caiteachais ar fhorchostais ar bhonn na gcaighdeán a aontaíodh leis an Stiúrthóir Airgeadais agus leis na Seirbhísí Tacaíochta agus a d'fhaomh an tArd-Stiúrthóir agus an Bord.

(B) AITHINT RIOSCAÍ GNÓ AGUS IMPLEACHTAÍ AIRGEADAIS

Mar a dhéantar go bliantúil san Fhoras, eagraíodh athbhreithniú riosca gnó le linn na bliana, a raibh an bhainistíocht shinsearach bainteach leis, agus aibhsíodh na rioscaí suntasacha a bhí ann do gnó an Fhorais Riaracháin agus na gníomhaíochtaí maolaithe a bhí riachtanach. I measc chórais faisnéise an Fhorais tá 'Integra', pacáiste comhtháite um chuntasaíocht bhainistíochta agus airgeadais. Tá modúil chomhtháite leictreona um rialú airgeadais ar an gcóras maidir le hioncam, caiteachas, féichiúnaithe, creidiúnaithe, ordú ceannaigh, párola, taistéal agus liúntas cothaithe foirne agus sócmhainní seasta. Tá formhór na rialuite próiseála faisnéise uathoibrithe laistigh de na córais leictreona; i measc na rialuite tá údarú cuí, dualgais a dheighilt agus doiciméadú agus taifid bhunaidh a scanadh. Rialáitear próiseáil faisnéise an Fhorais le sraith iomlán de nósannaimeachta rialithe.

Anuas ar sin, tá roinnt córas tacaíochta gnó lánpháirtithe sa chóras bainistíochta airgeadais (FMS). Oibríonn Rannóg Foilsitheoirreachta an Fhorais Riaracháin modúl um Próiseáil Orduithe Díolachán (SOP) ina bhfreastalaítear ar ordú díolachán, sonrascú agus rialú stoic. Baineann an Rannóg Oiliúna leas as córas comhtháite Oiliúna Riaracháin agus Bainistíochta (TAMS) chun próiseas áirithintí agus sonrasc na gcliant a bhainistiú. Maidir lenár gcláir Oideachais, bainistíonn córas comhtháite Faisnéise agus Riaracháin Mac Léinn (SIAS) clárú mac léinn agus bailiú táillí.

RÁITEAS MAIDIR LE RIALÚ INMHEÁNACH AIRGEADAIS

(D) NÓSANNA IMEACHTA CHUN MONATÓIREACHT ÉIFEACHTACHT A DHÉANAMH AR AN gCÓRAS RIALAITHE AIRGEADAIS

Uillmhaítar cuntais mhíosúla bainistíochta ina gcuirtear ioncam agus caiteachas buiséadaithe i gcomparáid leis an ioncam agus caiteachas iarbhír. Déanann an grúpa bainistíochta sinsearach athbhreithniú ar na cuntais seo. Déanann siad scrídú mionsonraithe ar na hidirbhearta agus na gníomhaíochtaí is bonn leo d'fhoinn iomláine agus cruinneas a chinntí. Cuirtear na cuntais seo faoi bhráid an Bhoird go ráithiúil.

Bíonn próiseas fairsing bliantúil buiséid i gceist, ina gceapann gach aonad buiséad mionsonraithe maidir le hioncam agus le caiteachas díreach, a ndéanann an Bord athbhreithniú agus faomhadh orthu. Uillmhaítar buiséid mhionsonraithe maidir le caiteachas caipitiúil chomh maith. Ina theannta sin, oibríonn an Foras córas forásach trí bliana de bhuiséadú ilbhliantúil.

Tá feidhm iniúchóireachta inmheánaí ag an bhForas ach déantar í a sheachfhoinsiú. Uillmhaítar clár iniúchóireachta mionsonraithe gach bliain agus déanann an Bord é a fhaomhadh trína Choiste Iniúchóireachta. Déantar athbhreithniú ar bhonn leanúnach ar an bplean iniúchta inmheánaigh. Athbhreithníonn an Coiste Iniúchóireachta na tuarascálacha iniúchóireachta a ullmhaítar, lena n-áirítear cur i bhfeidhm moltaí.

Déanann Rannóg Airgeadais an Fhorais monatóireacht ar idirbhearta ioncaim agus caiteachais chun géilliúlacht gach ceann de na haonaid ghnó a chinntí maidir le beachtas, bailíocht agus oiriúnacht.

(E) ATHBHREITHNIÚ BLIANTÚIL

Rinneadh athbhreithniú bliantúil ar rialuithe inmheánacha airgeadais an Fhorais a bhí i bhfeidhm i rith 2011. Rinne Bord an Fhorais athbhreithniú ar éifeachtacht na gcóras rialaithe inmheánaigh airgeadais ag a chruinniú an 9 Feabhra 2012.

(A) IONCAM

Déantar ioncam, arb é táillí agus deontas i gcabhair ón stát den chuid is mó é, a chur san áireamh ar bhonn infhaighteachta seachas suibscríbhinní a chuirtear in ioncam nuair a fhaightear iad. Tugtar táillí cúrsaí isteach sa Ráiteas Ioncaim agus Caiteachais le linn thréimhse an chúrsa.

(B) SÓCMHAINNÍ SEASTA AGUS DÍMHEAS

Tosaíonn dímheas sa bliaín a dtagann an tsócmhainn chun bheith in úsáid. Ní dhéantar dímheas ar thalamh. Níor ghlac an Foras le beartas athluachála; rinneadh athluacháil ar shócmhainní mar sin féin sular glacadh le Caighdeán Tuairiscithe Airgeadais 15 'Sócmhainní Seasta Inláimhsithe'. I gcomhréir le forálacha an chaighdeáin, choimeád an Foras na luachálacha seo mar a léirítear i Nóta 9.

(C) STOIC

Rinneadh stoic a luacháil go seasmhach le blianta roimhe sin, ag costas nó glanluach inréadaithe, cibé acu is lú. Tá soláthar déanta, nuair is gá, do stoc atá críon agus a ghluaiseann go mall.

(D) FÉICHIÚNAITHE

Déantar drochfhiacha aitheanta a dhíscríobh agus déantar socruite ar leith i dtaobh aon suimeanna a measfar nach dócha go mbaileofar iad.

(E) DEONTAIS CHAIPITIL

Caitear le deontais chaipitil a bhaineann le sócmhainní seasta mar chreidmheasanna iarchurtha agus déantar iad a amúchadh sa Ráiteas Ioncaim agus Caiteachais thar shaol úsáideach measta na sócmhainní.

(F) SÓCMHAINNÍ LÉASAITHE

Déantar sócmhainní a shealbhaítear faoi léasanna airgeadais a chaipitliú agus a áireamh le sócmhainní faoi úinéireacht den chineál céanna sa Chlár Comhardaithe. Áirítear comaoineacha faoi léasanna airgeadais le dliteanais, déantar iad a analísiú idir dliteanais reatha agus dliteanais fadtéarmacha. Cuirtear íocaíochtaí a dhéantar faoi léasanna oibriúcháin de mhuirear ar an Ráiteas Ioncaim agus Caiteachais.

(G) COSTAIS PIN SIN

Tá scéim pinsin sochair shainithe i bhfeidhm do gach fostai de chuid an Fhorais Riarachán, mar is cuí. I gcomhréir le forálacha an Acharta um Bearta Airgeadais (Forálacha Ilghnéitheacha), 2009, aistríodh sócmhainní chiste pinsin an Fhorais, a bhí tomhaiste ag luach cóir, go dtí an Cúlchiste Náisiúnta Pinsean (NPRF) ar an 30 Meitheamh 2010. Tá an scéim pinsin i bhfeidhm i gcónaí le haghaidh na mball reatha gan aon tionchar ar a leasa ná ar soláthar gaolmhar do bhaill.

Maidir leis an tréimhse go dtí 30 Meitheamh 2010, rinneadh an scéim a mhaoliniú le ranníocaíochtaí (ón bhForas agus ó fhostaithe) a aistríodh go ciste ar leith atá á riart ag iontaobhaí ar leith agus atá glan ó íocaíochtaí pinsinéirí agus costais na scéime. Ón 1 Iúil 2010, thóg an Foras Riarachán freagracht as bainistiú a dhéanamh ar íocaíochtaí a dhéanamh do phinsinéirí thar ceann an státhchiste. Faoin socrú nua beidh ranníocaíocht maoinithe an Fhorais fós ann agus beidh sí iníochta leis an Roinn Caiteachais Phoiblí agus Athchóirithe nuair a bheidh na pinsin a íocadh curtha san áireamh. Cuirfidh an Roinn maoiniú ar fáil sa chás go mbíonn na pinsin íoctha níos mó ná an ranníocaíocht.
