In terms of good governance, there is an increasing recognition of both the role of behaviours and attitudes, and of the quality and effectiveness of assurance arrangements and accountability processes (including external oversight of these systems). This discussion is increasingly focused on the nature and extent of the organisational assurance frameworks that exist and the role of management in confirming how they have ensured an effective, compliant and performance driven culture. The reviews of the effectiveness of the systems of internal control has brought an increased recognition on the role of risk management, audit, inspection and regulatory reviews in addition to the efficacy of internal business arrangements and the key roles of both executive management and nonexecutive board and committee members. The nature of the trust relationships that exist between those tasked with governance and leadership is also a critical factor in determining how governance and accountability is practiced within an organisation.

At this special half day conference, we are very pleased to have a range of expert contributors who will share their own insights and perspectives on the topic of trust, assurance and accountability. The event will also provide an opportunity for reflection and engagement and questioning. Among the questions to be considered are:

- To what extent does accountability rely on assurances and trustworthy behaviour and what are the implications of this reliance?
- Is the culture and environment of mistrust, distrust or low trust that pervades many aspects of organisational life inevitable and the appropriate driver of good governance?
- How can we ensure an appropriate balance between performance assurance and compliance assurance?
- What can we ensure an integrated assurance framework which is proportionate to the needs of modern organisations?
